

ENTRY/EXIT REQUIREMENTS:

A passport and visa are required. Travelers can obtain a renewable thirty-day tourist visa on arrival at an Egyptian airport for a \$15 fee, payable in U.S. dollars. **As we are arriving as a group Advantage International requires that you obtain a visa in advance of departing the U.S.** Visitors arriving overland and/or those previously experiencing difficulty with their visa status in Egypt should obtain a visa prior to arrival.

Proof of yellow fever immunization is required if arriving from an infected area. Evidence of an AIDS test is required for everyone staying over thirty days, for the purpose of studying or working in Egypt.
